Bestech has exclusive development rights for Park Inn by Radisson in central and northIndia, with the goal to develop 49 Park Inn by Radisson hotels by 2024 in north and central India.

Carlson Rezidor will manage the hotels through a management company in which Bestech is a partner.

The 11 states covered by the partnership are Chattisgarh, Chandigarh, Delhi, Haryana, Himachal Pradesh, Jammu, Kashmir, Madhya Pradesh, Punjab, Rajasthan, Uttar Pradesh and Uttrakhand.
